DIRECTIONS TO THE SHOW SITE!!

All officials and exhibitors with overnight parking reservations enter at Avenue 51 (just past Avenue 50) off Monroe.

From the west – From Interstate 10 eastbound, exit at Monroe and go right (south) approximately 4 miles just past Avenue 50 for day of show parking. Turn right Empire Polo Club Show Site and follow signs.

From the east – From Interstate 10 westbound, exit at Monroe and go (south) over the freeway (left) and proceed as above.

NO SETUPS IN DAY OF SHOW PARKING

Some parking areas may be some distance from your ring(s). An unloading area will be provided. Please follow the instructions of parking attendants. Day-of-Show parking will be \$10.00 per space. Vehicles requiring more than one space (motor homes, etc.) will be parked in the day-of-show overflow parking lot and will be charged \$10.00 per space used. No setups or x-pens will be allowed in day-of-show parking lots. No overnight parking will be allowed in the day of show parking lots. Anyone not following KCPS rules risks having his/her vehicle towed at owners' expense. No abusive behavior will be tolerated. KCPS and Empire Polo Club assume no responsibility for fire, theft or damage to vehicles or cargo, whether legally or illegally parked. Overnight parking is not permitted on the streets in Indio.

ATTENTION EXHIBITORS

Generators are allowed in the grooming/setup areas only and must be at least 50 feet from rings. No generators are allowed in day of show parking areas. No baby strollers are allowed.

TRANSFERS TO BEST OF BREED COMPETITION
